Closing date: Pre-entries will be accepted no later than Friday, March 21, 2025 at 5:00 pm, EDT

Classes offered:

Intro To Quarry (IQ):	Open to all eligible breeds, a non-regular class with no credit towards titles.
Novice (NE):	Open to all eligible breeds who have not previously earned an earthdog title
Junior (JE):	Open to all eligible breeds.
Senior (SE):	Open only to dogs who have earned a JE title.
Master (ME):	Open only to dogs that have acquired a SE title.
Endurance (EE):	Open only to dogs that have acquired a ME title.

A dog may be entered in any combination of the following classes, Intro to Quarry (IQ) (non-regular, non-titling class), Novice Earthdog (NE), and/or Junior Earthdog (JE), provided the dog is eligible for the classes.

Pre-entry Fees: IQ (non-regular) \$22 per entry; NE, JE, SE, & ME \$25 per entry. Dogs entered in the Junior Earthdog Excellent (JXE), Senior Earthdog Excellent (SXE), and Master Earthdog Excellent (MXE) classes should enter under JE, SE, and ME. Fees are \$25 per entry for these classes. Endurance Earthdog (EE) Exhibitors will receive a \$5 discount on SE & ME entries (\$45 for both runs). All pre-entry forms must be accompanied by entry fees to be valid.

"Day of": "Day of" Entries will be accepted for all classes. "Day of" entries close 30 minutes prior to the start of each event. The club reserves the right to limit "Day of" entries.

Move-ups: Move-ups are accepted until 8:15 a.m. for the morning events; 12:00 noon for the afternoon event.

Refunds: There will be no refunds for entries withdrawn after the closing date or in the event that a dog and/or his handler are dismissed from competition regardless of the reason for such dismissal, except for bitches in heat. No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Event Committee.

Bitches in season may not be entered. Entry fees will be refunded (except for the \$3.50 AKC fee) for bitches in season with a veterinary certificate or presentation of the bitch to the committee. A request must be made before 8:00 AM on the day of the entered test.

Dogs sick/injured. GITCA will refund total entry fees less \$10.00 per day for dogs that become sick/injured after the closing date. A veterinarian's certificate must be presented to the Trial Secretary prior to the start of judging on Saturday.

Earthdog Practice will be offered on Friday March 28, 2005 beginning at 1:00 PM:

Each Judge will present a special memento as a "Judge's Choice Award" after the 3rd trial based on all performances (qualifying or not) sponsored by Greystone Hollow.

Check-In and Running Order

Entrants must check in prior to the start of their class (times noted above). Exhibitors not appearing when called will be moved to the end of the order. Dogs will run in the order entries are received with consideration given to multiple dogs with the same handler, dogs entered in multiple classes, volunteers and workers.

Dogs entered by the closing date that qualify to enter a test other than the one on their entry form may have their entry changed by contacting the Test Secretary by 8:00 AM on test day.

Eligible Breeds: Dachshunds and the following terrier breeds: American Hairless Terrier, Australian, Bedlington, Border, Cairn, Cesky, Dandie Dinmont, Glen of Imaal, Jagdterrier, Japanese Terrier, Smooth Fox, Wire Fox, Parson Russell, Lakeland, Manchester, Miniature Bull, Miniature Pinschers, Miniature Schnauzer, Norfolk Norwich, Rat, Russell, Sealyham, Scottish, Silky, Skye, Welsh, Teddy Roosevelt, West Highland White, and Yorkshire. Dogs must be 6 months of age and registered with the AKC or have a PAL/ILP granted by the AKC. A dog of eligible breed with an acceptable foreign registration number is eligible to participate subject to Chapter 11, Sec.1 of the Dog Show Rules.

The safety of the dog is GITCA's primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are able to perform safely. The trial site is not fenced. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the test committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made. The GITCA will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The GITCA reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against GITCA or any official thereof.

All dogs must be confined or on leash except when judged. No Flexi-leads or prong collars allowed on site.
